CENTRAL MICHIGAN HOME SHOW
Rules and Regulations

THE FOLLOWING RULES AND REGULATIONS ARE DESIGNED TO INSURE AN ORDERLY AND HARMONIOUS RELATIONSHIP BETWEEN EXHIBITORS AND THE HOME BUILDERS IN CONNECTION WITH THE CENTRAL MICHIGAN HOME SHOW. THIS CONTRACT IS SUBJECT TO THE FOLLOWING RULES AND REGULATIONS.

1. Each single booth size will be 10 feet wide and 10 feet deep. All multiple booth rentals will be based upon the single booth space size.
2. The number of booth spaces and location will be determined solely by the Home Show Committee. Builders and Association members may be given preference with respect to booth locations. Booth spaces may not be sub-let.
3. If the number of booths requested is not available, you may (1) cancel this Contract and receive a full refund of monies paid: or, (2) accept the number of booth spaces available and receive a partial refund for the number of booth spaces not available. Your acceptance of a partial refund will constitute your acceptance of the number of available booth spaces. Once booth spaces have been allocated and accepted, no money will be refunded in the event you subsequently withdraw from the show.
4. All products and services must pertain to home building, remodeling, home products or the home building trade. All booths will be viewed by Home Show Committee prior to the opening of the show for conformity. The Home Show Committee will be the sole judge of conformity. In the event any booth contains exhibits, products or displays which, in the sole and final decision of the Home Show Committee, do not conform to the purpose of the Home Show, the Exhibitor will be instructed to remove the non-conforming items from the exhibit prior to the opening of the show. If the objectionable exhibits are not removed prior to 4:00 pm on Friday prior to the show, the Exhibitor authorizes the Home Show Committee to remove the non-conforming material and store the same for release to the Exhibitor. In the event it is necessary for the Home Show Committee to remove non-conforming exhibits, it is agreed that Exhibitor shall pay to the Home Builders Association of Central Michigan, Inc., the sum of One Thousand (1,000) Dollars as liquidated damages for services rendered in connection with the removal and storage of non-conforming materials. The Home Builders Association of Central Michigan, Inc., shall have a lien upon all stored materials pending the payment of liquidated damages. All parties agree that the amount of damages stipulated herein does not represent a penalty but rather represents liquidated damages which are reasonable in light of the anticipated or actual harm caused by the Exhibitor's failure to remove objectionable exhibits.
5. All booths and exhibits must be completely in place and set up by 4:00 pm on Friday. Removal of the exhibit and clearing of the booth will commence at 4:00 pm on Sunday, and must be completed no later than 7:00 pm on Sunday. In the event the booth is not cleared by 7:00 pm on Sunday, the Exhibitor authorizes the Home Builders Association of Central Michigan, Inc., to remove and store the booth contents. In the event it is necessary for the Home Builders Association of Central Michigan, Inc., to remove the stored material, the Exhibitor shall pay to the Home Builders Association of Central Michigan, Inc., the sum of One Thousand (\$1000) Dollars as liquidated damages for services rendered in connection with the removal and storage of materials. The Home Builders Association of Central Michigan, Inc., shall have a lien upon all stored materials pending the payment of liquidated damages. All parties agree that the amount of damages stipulated herein does not represent a penalty but rather represents liquidated damages which are reasonable in light of the anticipated or actual harm caused by the Exhibitor's failure to remove the exhibit by Sunday evening at 7:00 pm.
6. All personnel working in the booths must wear an Exhibitor's identification badge for admittance to the Show. **The names of all personnel staffing Exhibitor's booths must be submitted to the Home Builders Association by February 19, 2010.**
7. No sound equipment or sound making devices which are objectionable or can be heard outside of your exhibit area will be permitted. Alarm systems may not be activated during Show hours. Any deviation from this rule must be first reviewed with the Home Show Committee. The Committee's decision with respect to the same shall be final.
8. *Liability & Indemnity:* All goods, wares, and merchandise of any kind placed in the Home Show are understood to be at the owner's risk, and by acceptance of this contract, the Exhibitor releases the Home Builders Association of Central Michigan, Inc. and Central Michigan University of and from any liability or damage, injury or loss to any person, or goods, from any cause whatsoever. Exhibitor shall indemnify, defend and hold harmless the Home Builders Association of Central Michigan, Inc. and Central Michigan University from and against all claims, actions, liabilities, damages, losses, costs and expenses, including but not limited to attorney's fees, arising out of or related in any way to any act or omission of Exhibitor, its agents, employees or representatives. There will be **NO SECURITY** on the premises, day or night.
9. You may sell from your booth within perimeters of your booth space. You are responsible for all the necessary security of your goods and your cash. Exhibitor shall be responsible for payment and reporting of all sales taxes.
10. Exhibitors shall not engage in any disruptive conduct of any kind. Failure to do so shall result in the expulsion of the exhibitor from their booth for the remainder of the Home Show. In the event of this happening, no refund of any kind will be paid to the exhibitor.
11. **ABSOLUTELY NO TRUCKS, CARS OR HEAVY EQUIPMENT IN THE INDOOR ATHLETIC COMPLEX AT ANY TIME!** Track surface must be protected. Weight limit at discretion of Home Show Committee.
12. **NO** helium balloons in your display or to be given away.
13. Tear down procedure at discretion of Home Show Committee. Please allow 3 hours.
